## **Current problem**



#### **Situation**

- Large purchases are done via European Public Procurement procedures by experts with the education, knowledge and experience
- Small purchase are done by people who purchases once in a blue moon

## Main problems with direct procurement

<u>User ability</u>
 lack of time and expertise to legally,
 effectively and correctly follow
 the appropriate procedure

	European Public Procurement	Direct Procurement
Legal Framework	Regulated by EU Directives	National or local regulations
Procedures	Competitive, open tenders	Simplified, direct negotiations

• <u>Socially Responsible Public Procurement (SRPP)</u>
difficulties in selecting impactful businesses and in meeting SRPP policy objectives

**These issue lead to** inefficiency, a less diverse supplier base, not always selecting the best contractor, and often failing to meet policy objectives such as sustainability, social responsibility, and positive impact on local economy

# Tool for direct procurement **6**



#### Goal

A digital tool that guides the incidental purchaser through the procedure of direct procurement

#### It should be

- Easy to use, intuitively, time-saver, efficient, no knowledge or experience required
- Meet security and privacy criteria, such as GDPR
- Follow the right procedures (including "please go to the experts")
- Achieve Socially Responsible Public Procurement
  - Recommendations on preferred suppliers from preferred suppliers lists, such as
  - European Innovation Awardees and "Kennemer Inkoop Platform" (local impact businesses)
  - Use the latest SRPP criteria in the request for quotation, such as www.mvicriteria.nl
- Automatically provide
  - Requests for quotation (either to 1 business or to 3-5 businesses)
  - Contract with legal criteria, such as the inclusion of General Terms and Conditions
  - File for archiving
- Focus on the end-user: easy to use is key!
